1. About IIT DHARWAD

Indian Institute of Technology DHARWAD (IITdh) is one of the Centrally Funded Technical Institutes (CFTI), an Institution of NATIONAL IMPORTANCE which is also one of the six third Generation (3-G) IITs established by the Ministry of Education (MoE), Government of India (GoI). It was started in August 2016 under the mentorship of IIT Bombay. There are currently

B. Tech, MS/M. Tech by Research and Ph.D. programs running with more than 1300 students on the campus.

Applications are invited from eligible Law Firms/Associates/Lawyers for empanelment to represent IIT DHARWAD before different Courts of Law and provide legal advice in administrative matters whenever referred to.

2. Expression of Interest (EoI) for Empanelment of Law Firms/Associates/Lawyers

Those Law Firms/Associates/Lawyers enrolled with respective states *Bar Councils in India* are eligible for empanelment for representing and assisting the IIT DHARWAD before various Courts, Fora and Tribunals/Commissions etc. as well as to support the Institute as an advisor. All Interested and Eligible Law firms/Associates/Lawyers may submit their EOI as per the schedule mentioned in this document.

3. Eligibility Criteria: -

The eligibility criteria for empanelment shall be as under: -

- a. In case of Law Firm, it must be registered under Companies Act, 2013 or a partnership firm registered under Partnership Firm Act 1932 or Limited Liability Partnership Firm registered under Limited Liability Act, 2008 in India with valid license to practice law and provide legal advice in India. Associates/ Individual Lawyers should be enrolled with respective Sate Bar Councils.
- b. The Law Firm/Associates/Lawyers should have a minimum of 10 (ten) years of experience and should have worked and completed at least 5 cases/legal matters every year during the last three financial years or cumulative total of at least fifteen cases during the same period for corporate clients/Govt. organization/Educational institutes/Autonomous bodies/PSUs (relevant documents in support of experience must be enclosed).
- c. The adequate weightage will be given to Law Firms/Associates/Lawyers who are empaneled with the State or Central Universities for at least two years in the past.

- d. The Law Firm/Associates/Lawyers should have an office existing operational with adequate infrastructure at Hubballi-Dharwad/Belagavi to deal with the matters.
- e. Any Law firm/Associate/Lawyer who have been barred/whose sanad has been suspended by the Bar Council (State or Central) shall not be eligible to apply.

4. Scope of Work: -

The empaneled Law firm(s)/Associates/Lawyer shall be required to assist the IIT DHARWAD in the following activities as assigned from time to time.

- a. To provide advice/legal vetting of any legal documents of projects or any other legal assistance arising out of the functions of the Institute
- b. Assistance in drafting regulations, notices, policies or Manual of Institute etc. Legal vetting of orders, decisions, concept papers, bidding/tender documents, undertakings / indemnity bonds / Agreements / Contracts / MoU*/ MoA*/ NDA@ / Deeds / Petition Reply etc. to be obtained from entities.
- c. Review of regulations based on practical working at IIT DHARWAD.
- d. Review / Concur and support/draft other legal documents and services which IIT DHARWAD may require from time to time to carry out its operations.
- e. To prepare various record note of proceedings of various hearings, handling matters before any courts.
- f. To perform such other work of legal nature as may be required by IIT DHARWAD from time to time.
- g. To take up arbitration cases for the Institute (if any) arising out of any contract, Agreement etc.
- h. To keep IIT DHARWAD informed and updated on all-important developments in the designated cases, dates of hearing, orders of the court on the date of its pronouncement, supply copy of such orders /judgment etc.

5. Terms & Conditions of Empanelment:

- a. The initial term of empanelment of the Law Firms/Associates/Lawyers will be for one year and extendable up to extendable up to maximum three years on an year to year basis subject to satisfactory performance.
- b. IIT DHARWAD reserves the right to select any number of Law Firms/Associates/Lawyers for empanelment or none of them without assigning any reason.
- c. This empanelment is liable to be terminated by giving one month's notice on either side. At its discretion, IIT DHARWAD may assign Court Cases / Matters to any one of the Law Firms/Associates/Lawyers in the panel and no Law Firm /Associates/Lawyer has right to claim for such assignments of Court Case/Matter.
- d. Upon termination or non-renewal of the acknowledgement concerned, the Law firm/Associates/Lawyer shall return the brief to the IIT DHARWAD along with connected documents and records with no objection certificate.
- e. Empanelment with this Institute does not ensure business of any quantum whatsoever. The institute reserves the right to engage other advocates/firms for similar work. Any deviation from the Terms & Conditions mentioned above will imply disqualification of the Law firm/Associates/Lawyer.
- f. The advocate/representative of the law firm/associates must visit IIT Dharwad as and when the requirement arises, with preference for a physical visit; however, electronic communication may be utilized wherever necessary.
- g. Courts at DHARWAD will only have jurisdiction to try Institute's legal matters, disputes or reference between parties arising out of this EOI.

6. Fee and Expenses

- a. The empaneled Law Firm/Associates/Lawyer shall be paid a fixed fee of INR 5000/-for every written opinion/advice/legal vetting of documents of any project/drafting of legal documents or any other legal assistance availed by IIT DHARWAD.
- b. The following are the charges for every drafting/filing a writ petition/written submission to the Courts

c. The following charges apply for presenting a case or attending a hearing in court that requires the physical presence of the lawyer. The charges are on a per-day basis.

7. Documents required to be submitted by the Law Firm/ Associates/Lawyers

- a. Registration of the Law Firm/ Registration of the Associates/Lawyers with the Bar Council (as applicable)
- b. Profile as per format provided at Annexure I
- c. Identity card issued by Bar Association/ Bar Council. Law Firm/Associates/Lawyers must submit a copy of the empanelment letters and or experience certificates from the client organizations in support of their minimum experience as per Annexure II. It is preferable to mention the type of legal affairs handled.
- d. Certificates in support of the **educational qualifications** of the Head/Director/Senior Partner shall be submitted in the case of law firms or associates. In the case of an individual lawyer, the relevant educational qualification certificates of the lawyer must be submitted.

- e. A self-certification from authorized signatory that the applicant has not been blacklisted/barred/penalized and that all the information furnished is correct (As per **Annexure III)**.
- f. Income Tax Return certificate for the last three financial years as per **Annexure** IV.
- g. Copies of empanelment with state or central universities as per Annexure V
- h. Copy of Certificate of Incorporation or partnership deed or other equivalent documents (for Law Firm/Associates as applicable)
- i. Details of any court cases/arbitration cases/ or any other case pending against the Applicant (if any).
- j. Details on cases handled in the last three years (Refer to Annexure VII)
- k. Other documents as required in the eligibility criteria to fulfill the conditions.

8. Submission of EoI:

The applications for empanelment shall be submitted in a sealed envelope and sent through courier/speed post to the address mentioned below. The applications must be complete in all respects and accompanied by all supporting documents. Incomplete applications shall be rejected without any notice by the Institute. The Institute shall not be responsible for any postal or courier delays. The envelope should be superscribed with 'Notice for Empanelment of Law Firms/Associates/Lawyers'
