- 3. The deadline to confirm your acceptance of admission and the deadline to pay the fee are the same. The refund of fees is as per the Institute's norms.
- 4. Tuition fees for External Category students and Sponsored Candidates are ₹.25,000/-.
- 5. All the students are required to pay the entire fee as per the fee circular. The students who wish to reside outside may be permitted to do so with the permission of the institute, only after reporting to the campus. The respective fee components related to the hostel and mess advance will be reimbursed later with the approval of the competent authority.

The following procedure may be adhered for the payment of fee:

1. Students may pay fees through SBI Collect by visiting the below-mentioned link > (M.Tech(R)/PhD(NEW ADMISSION)):

- 2. In case of fees being paid through (a) loan from a Bank, or (b) a sponsoring agency (private/government), the student must generate a challan on the SBI Collect Portal using either the Branch or NEFT option:
- * For students who have taken a loan from SBI: In the payment gateway, select the Branch option, generate the challan, and then visit or share the generated challan with the SBI branch to complete the fee payment.
- * For students who have taken a loan from non-SBI banks: In the payment gateway, select the NEFT option, generate the challan, and then visit or share the generated challan with the respective bank to make the fee payment.

After the fee payment is successfully completed, the fee receipt will be generated automatically, and the student can download the same.

Students paying fees through online fee payment must ensure that their transaction is completed in all respects. Students who fail to pay the fees before the deadline, their admission is liable to get cancelled without any further information/notice.
